A. COUNCIL BUSINESS

a. Muskrat Followup

Mayor Matt Lein reviewed the information provided from City Administrator Jesse Dickson regarding a solution to removing muskrats from the stormwater pond in the Hans Hagen Development. Francis Pest Control recommended the trapping be done during the summer and suggested a fence around the ponds would keep the muskrats out. Cost to set up the traps initially would be \$200.00 and every muskrat caught would be a \$90.00 charge.

Mayor Matt Lein was inclined not doing anything at this time. Evenski can we table it indefinitely and re- visit in the early spring and summer.
