

City of Cologne
JULY 15, 2013

Pursuant to due call and notice thereof, a council meeting was held on Monday, July 15, 2013 at the Cologne Community Center. Mayor Matt Lein called the meeting to order at 7:00 p.m. Councilmembers, Jeffrey McInnis, Scott Williams and Don Meyer were present. City Administrator John Hendel and Deputy Clerk Sue Mueller were present.

City Administrator requested the following changes to the Agenda:

- Table c) City Logo Discussion
- Add e) Street repair update
- Add f) Jaguar Communications phone proposal
- Add g) County Road 36 watermain loop

ADOPT AGENDA

Motion by Meyer to adopt the revised Agenda, seconded by McInnis. Motion passed unanimously.

ADOPT CONSENT AGENDA

Motion by Meyer, seconded by Williams, to adopt the Consent Agenda. Motion passed unanimously.

VISITORS PRESENTATION

a) Cologne Hollanders Baseball-Legion Tournament Update

Craig Pexa updated the Council on plans for the Cologne Hollanders hosting the regional baseball- tournament held two consecutive weekends in July: July 19-July 21st and July 26-July 28th. Craig reviewed the plans for parking, which were coordinated with the Cologne Lions Club.

COUNCIL BUSINESS

a) Klein Bank

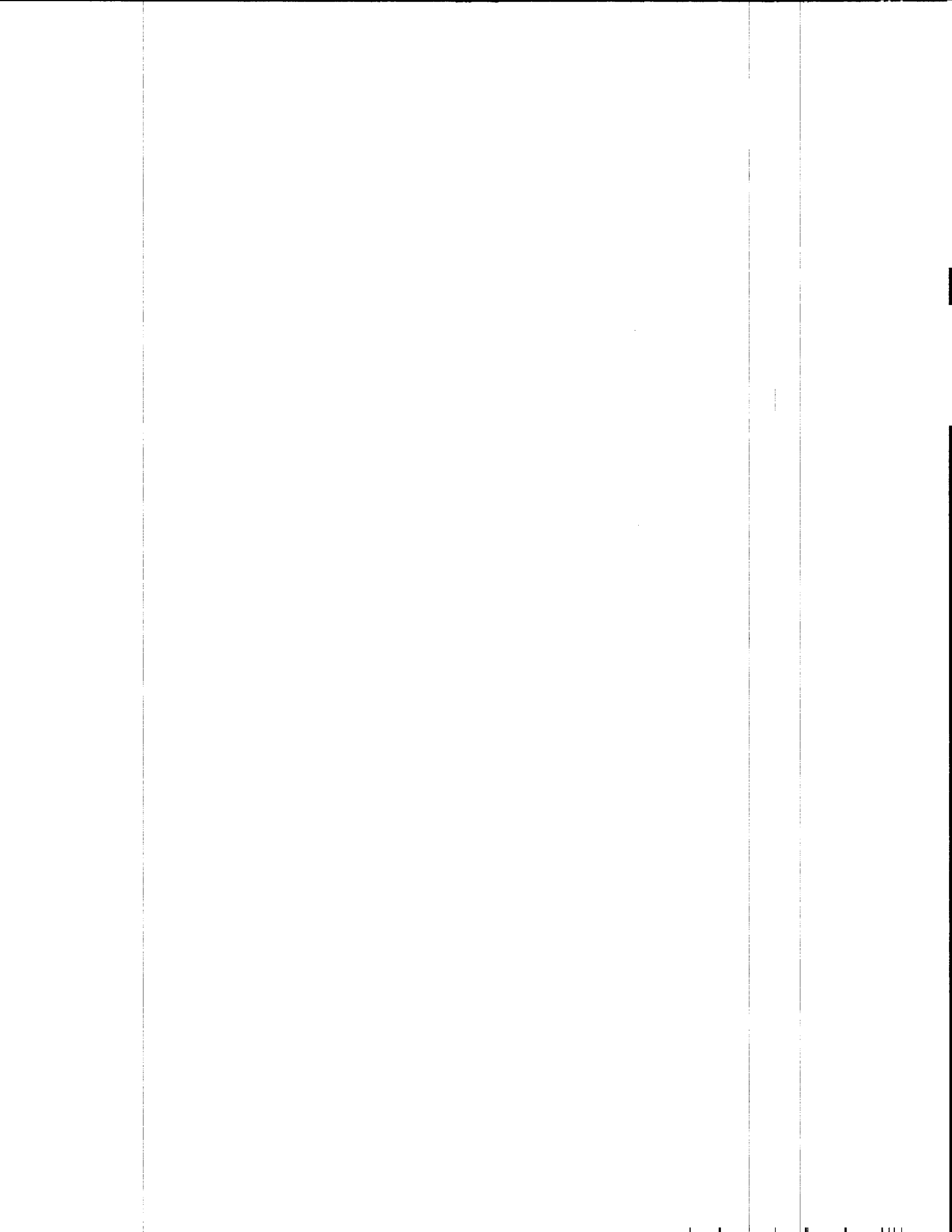
Administrator John Hendel updated the Council on comparisons between Security Bank of Waconia and Klein Bank. Administrator Hendel reported Klein Bank has some resources available that would be of benefit. Staff recommended the Council approve the use of both Security Bank and Klein Bank for city business.

Motion by Williams, seconded by McInnis, to approve banking with Klein Bank and Security Bank. Motion passed unanimously.

b) City Uniforms

Administrator John Hendel presented two bids for city uniforms; Ameripride Inc., the current vendor, and G & K Services. G & K Services was able to provide more services at a lower price than Ameripride. Staff recommended Council approve the uniform allowance for the public works department and award the bid of G & K Services.

Motion by Meyer, seconded by McInnis, to approve the bid from G & K Services for city uniforms and building maintenance. Motion passed unanimously.



c) City Logo Discussion

Administrator John Hendel presented the Council with a draft of options for a new city logo. The city currently has multiple logos on water towers and in use on office supplies. City staff would like to transition from the multiple logos that are currently being used to one. Administrator Hendel reported the transition may take one to two years. Council members tabled any decision at this time.

d) Vacant Council Position

Kyle Evenski, 2016 Cobblestone was in attendance and gave a brief summary of why he is a candidate for the vacant council chair. After some discussion regarding attendance at council meetings, the Council approved the appointment of Kyle Evenski to the City Council.

Motion by Williams, seconded by McInnis, to appoint Kyle Evenski to the City of Cologne Council. Motion passed unanimously.

e) Street Repair Update

Administrator John Hendel reported on the street repair work for this summer. Wm Mueller bid \$58,487.60 for pothole and street reconstruction, Barga Inc. bid \$6,536.70 for crack sealing and Pearson Bros., Inc. bid \$44,145.09 for seal and chip coating and the possible mill overlay of Playhouse Street. Administrator Hendel explained a portion of the repair work was budgeted and the local government aid the city is receiving is higher than originally projected. Councilmember Don Meyer stated some of the streets are in need of repair and advised the repairs be started.

Motion by Meyer, seconded by McInnis, to approve the street repair project up to \$116,000. Motion passed unanimously.

f) Jaguar Communications Phone Proposal

Administrator John Hendel presented a proposal from Jaguar Communications for the city phone system. Hendel reported switching from Centurylink to Jaguar Communications will save the city some money.


Motion by McInnis, seconded by Meyer, to approve the Jaguar Communications phone proposal. Motion passed unanimously.

g) County Road 36 Watermain Loop

Administrator John Hendel reported Bolton and Menk has an application for water system improvements, and will keep the city informed of any new developments. Administrator Hendel reported this project should be something the council should keep in mind for the future.

Motion by Williams, seconded by Meyer to adjourn the meeting. Motion passed unanimously.
