ADOPT AGENDA

Motion by Meyer seconded by Evenski to adopt the consent agenda. Motion passed unanimously.

VISITORS PRESENTATIONS, PETITION AND CORRESPONDENCE

Betsy Pysick and Paula Gort, representatives from the Glad Days Committee came to talk about the event this year which will take place July 24 – 26. The theme is Wild West. The group requested that the City pay for the tent, stage, garbage dumpster and portable bathrooms. After their presentation, a motion was made by Meyer and seconded by McInnis to pay for the requested items. All voted in favor, motion passed.

Motion by McInnis, seconded by Szaroletta to accept the City of Cologne Employee Policy Book Reference Manual March 2015 as the current manual, which supersedes any and all previous versions. Motion passed unanimously.

d. Fitness Center Equipment

City Administrator John Hendel presented information on replacing some of the fitness equipment in the fitness center. After some discussion, Council directed staff to conduct a survey with the membership to see what they would like to see.

e. Discussion and Next Steps-City Administrator Candidate Interviews

After discussing the second interviews with the three finalists for City Council, a secret ballot was taken of which Jesse Dickson received 4 votes and Adrian Well received one vote. Salary ranges were discussed for the new administrator. Motion by Evenski, seconded by Szaroletta to offer the position to Jesse Dickson pending a background check and drug test along with involvement by Kelly Dohm to put together the offer letter. Starting salary to be \$60,000 per year. Motion passed unanimously.
