COUNCIL BUSINESS

a) Resolution No. 17-05 Approving Public Works Capital Expenditure

City Administrator Jesse Dickson, Public Utilities & Maintenance Supervisor Brian Vos and Public Works Employee Mark Eggers reported the city has budgeted \$100,000.00 for a new pickup truck and plow and a skid loader. Brian Vos presented quotes for equipment, as well as trade-in values of old equipment. City staff recommends purchasing the Bobcat S650 Skid Loader for \$26,574.95 from Lano Equipment, the 9'2" V plow for \$6,045.00 from UFC and the 765-9.5' SS Tipper Box for \$18,972.25 from Crysteel.

Brian Vos reported the 2006 Bobcat will be traded in for \$16,400.00 and the snow blower attachment for \$2,500.00 to Lano. Staff requested the Council approve \$48,407.80 for the capital outlay.

Motion by Evenski seconded by Szaroletta to approve Resolution No. 17-05 Public Works Capital Expenditure. Motion passed unanimously.

b) Plow Truck Purchase

Public Utilities & Maintenance Supervisor Brian Vos and Public Works Employee Mark Eggers presented two quotes from Midway Ford for the purchase of a new truck.

- 2017 F-550 4x4 Super Cab-60" (Extended Cab) \$46,825.00
- 2017 F-550 4x4 Regular Cab-60" \$44,100.00

Brian Vos reviewed the advantages/disadvantages for a Super Cab vs a Regular Cab. Brian Vos and Mark Eggers recommended the regular size cab as the turning radius during snow plowing is easier than the extended cab. Brian Vos also reported the regular cab will be easier to store in the public works shop, with the plow attached prior to any snow storms.

Motion by Meyer, seconded Szaroletta to approve the purchase of the 2017 F-550 4x4 Regular Cab-60" for \$44,100.00 to include the dump body. Motion passed unanimously.
