COUNCIL BUSINESS

2018 GIS Utilities Mapping Project

Please find attached to this memo a series of examples of the GIS technology being utilized by some of our neighboring Cities.

- 1. The first image is a mock-up of a fire hydrant map for Cologne. The data was pulled from CAD maps from Bolton & Menk and some as-built plans. The data is inaccurate but is meant to show how a hydrant map would work. If the City opts to use this technology, the hydrants will be mapped accurately.
- 2. The second image is a full utilities map of the City of Mayer. Water, sewer, and storm sewer lines are all shown along with things like manholes and gate valves.
- 3. The third image is the sewer portion of the City of Mayer. Please refer to the legend on the left side of the image to interpret what each symbol means.
- 4. The fourth image is the storm sewer portion of the City of Mayer. Please refer to the legend on the left side of the image to interpret what each symbol means.
- 5. The fifth image is the water portion of the City of Mayer. Please refer to the legend on the left side of the image to interpret what each symbol means.
- 6. The sixth image is from the City of Watertown. The information is incomplete as Watertown is currently implementing this software, but it shows their water system so far. Watertown chose to label each water line by size, which is extremely helpful. The City of Cologne has water maps that state the size of the lines but they are often outdated and inaccurate.

The final image is a dashboard used by the City of NYA for their snow plowing. Each truck is tracked to keep track of hours and the amount of salt and brine that are used. This data is helpful not only for budgeting but also for maintenance data.

The City of NYA also uses a similar dashboard for their lawn mowing operations during the summer but we were not given access to that information.

Councilmember Kyle Evenski asked what are the limitations for the cost to pay for the system. City Administrator Jesse Dickson reported the only added cost would be the cost to share with with other communities. Councilmember Kyle Evenski asked if Watertown has shown interest in this. City Administrator Jesse Dickson reported a joint effort potentially with New Germany and Watertown.

Fire Chief Nick Joss reported this would cut down the cost of having the cost of inspecting road, MN DOT is recommending based off of the new technology.

Councilmember Kyle Evenski if we purchase it we have the machine. Mayor Matt Lein can we require new builders to provide the information to the city?

City Administrator Jesse Dickson licensing would be \$1000-\$1500 per year per license then the cost of sharing with Watertown and other communities. Plus additional cost for staff.

Public Works Superintendent Brian Vos Conrad Street no curb-stops/or sewer services located on current maps. This GPS would be able to locate the lines. Mayor Matt Lein this would be able to locate the size of the sewer and water lines.

Fire Chief Nick Joos years ago the County provided information to the Fire Department. Benefits the Fire Department for future Fire Department members when the new people are not familiar with the town compared to seasoned Firemen. Really would benefit with having the new technology.

Councilmember Kyle Evenski reported he is comfortable with moving forward but would like to get more information on partnering with other communities for sharing of the cost of it.
