- a) Eide Bailly LLP-Final 2012 Audit
 - Joel Stensel of Eide Bailly reviewed the 2012 Audit. Mr. Stencel reported in fiscal year 2012 the City of Cologne had \$1.73 million in cash reserves in the general fund with increases of both revenue (\$1.47 million) and expenses (\$1.4 million). The storm sewer fund had some significant increases for repairs and maintenance.
- b) The Village at Cologne Fifteenth Addition-Addendum to Developer's Agreement City Planner Dean Johnson reviewed the Village at Cologne Fifteenth Addition Final Plat. Dean reported the lot layout is consistent with the approved Preliminary Plat/PUD for the Village at Cologne. Administrator John Hendel reported the Planning Commission recommended approval.
