

## CITY OF COLOGNE RESOLUTION NO. 14-09 RESOLUTION TO MAINTAIN SIGN RETROREFLECTIVITY STANDARDS AND ESTABLISH SIGN REPLACEMENT

WHEREAS, the City of Cologne has been advised that it is required to initiate a process of evaluating its City public road signs for reflectivity and further, to initiate a plan for replacing existing City public road signs that do not meet the new retroreflectivity standards mandated by the Federal Highway Administration (FHWA); and

WHEREAS, the City of Cologne has reviewed the documents from Bolton & Menk regarding sign replacement; and

WHEREAS, the City of Cologne Public Works department has created a sign inventory of current public roads signs that are the responsibility of the City; and

WHEREAS, the City of Cologne Public Works staff is recommending the replacement of the signs on the inventory list, which covers all public road signs under the City's responsibility; and

WHEREAS, the City of Cologne wishes to establish a sign replacement program for future years which is in line with the standards established by the Federal Highway Administration (FHWA); and

WHEREAS, the City Council wishes to not only memorialize its new retroreflectivity signage standard but to also devise and implement a plan to replace signs that do not meet the new retroreflectivity standard, and wishes to formally do so by this resolution.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Cologne, Minnesota, that the following constitutes its standards, policies and plans relative to retroreflectivity road signage:

- 1. The signage sheeting standard for all new or replacement City road signs is "High Intensity Prismatic" (HIP)
- 2. All new or placement road signs installed by the City from the date of this resolution forward will be at a minimum of the "High Intensity Prismatic" (HIP) type.
- 3. The City of Cologne Public Works has conducted a tour of all of its roads for the purpose of creating a complete inventory of its public road signs, with such inventory noting for each sign, its location, type and general condition.
- 4. The City of Cologne will do a blanket replace of all City road signs in the calendar year 2014.

5. On an on-going basis, the City's annual road inspection tour will include a notation for any signs appearing to need replacement that may differ from what is stated and scheduled in the City's traffic sign retroreflectivity compliance policy.
