



CITY OF COLOGNE RESOLUTION NO. 16-25 RESOLUTION TO APPROVE SALE AND SPLIT OF CITY PROPERTY

WHEREAS, the City of Cologne approved a purchase agreement on August 15, 2016 to sell two pieces of parcel #400500633 ("City parcel") to Cologne Enterprises, LLC; and

WHEREAS, the sale requires the City parcel to be split into two new pieces ("Tract A" and "Tract B"); and

WHEREAS, the proposed legal descriptions of Tract A and Tract B are as follows:

Tract A

That part of Lots 1 and 2, Block 15 and that part of vacated Mill Street, all in Village of Benton City, according to the recorded plat thereof, City of Cologne, Carver County, Minnesota, described as follows:

Commencing at the northeast corner of said Lot 1; thence North 02 degrees 29 minutes 50 seconds East (assumed bearing) on the northerly extension of the east line of said Lot 1, a distance of 25.01 feet to the point of beginning; thence South 02 degrees 29 minutes 50 seconds East on said east line, 73.48 feet; thence North 47 degrees 00 minutes 37 seconds West, 32.39 feet; thence North 70 degrees 19 minutes 09 seconds West, 111.85 feet to a point on the centerline of vacated Mill Street; thence North 88 degrees 55 minutes 09 seconds East on said centerline, 153.52 feet to a point on the northerly extension of the east line of said Lot 1, said point also being the point of beginning.

Tract B

That part of vacated John Street, according to the recorded plat of Village of Benton, City of Cologne, Carver County, Minnesota, described as follows:

Commencing at the northeast corner of Block 15, said plat of Village of Benton City; thence South 02 degrees 29 minutes 50 seconds East (assumed bearing) on the east line of said Block 15, a distance of 59.99 feet; thence North 88 degrees 55 minutes 09 seconds East, 5.41 feet to the point of beginning; thence North 88 degrees 55 minutes 09 seconds East, 19.60 feet to a point on the centerline of said vacated John Street; thence South 02 degrees 29 minutes 50 seconds east on said centerline, 79.80 feet; thence South 88 degrees 55 minutes 09 seconds West, 7.00 feet; thence North 03 degrees 10 minutes 35 seconds West 40.00 feet; thence North 19 degrees 18 minutes 36 seconds West, 41.91 feet to the point of beginning.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Cologne, Minnesota, that the sale of Tract A and Tract B from parcel #400500633 be approved.
