- 2. <u>Notice of Hearing; Filing of Program and Plan</u>. The City Administrator is hereby authorized to cause a notice of the hearing, substantially in the form attached hereto as Exhibit A, to be published as required by the Act and to place a copy of the proposed Development Program and Tax Increment Financing Plan on file in the Administrator's Office at City Hall and to make such copies available for inspection by the public.

The motion for the adoption of the foregoing resolution was duly seconded by Councilmember Bruss and upon vote being taken thereon, the following voted in favor: Lein, Evenski, Bruss, Szaroletta
