1. CALL MEETING TO ORDER & ROLL CALL

Mayor Matt Lein called the meeting to order at 7:00 pm. Council Members Evenski, Szaroletta, Bruss and Spates were present. Also present: City Administrator Jesse Dickson and City Clerk Michelle Morrison.

4. VISITOR'S PRESENTATIONS, PETITIONS, CORRESPONDENCE

Mayor Lein introduced Gianluca Schaeben and Tobias Politt, who arrived at City Hall this afternoon to visit. They came from Koln, Germany and while mapping out their planned visit to the States saw our City and included the visit on their itinerary. They brought gifts from their city for us, most significant is a piece of stone which was reclaimed from the Koln Cathederal, along with picture books of Koln's History - all of which will be put in our showcase window in City Hall.

Administrator Dickson provided the council clarification on State Statute Chapter 429, the Xcel Public Works payment and the Solar Energy Partnership.

6. COUNCIL BUSINESS

a. Franchise Fees

Administrator Dickson reviewed the concept/purpose of Franchise Fees and provided an update regarding what cities in the area currently have Franchise Fees and how they are structured. A possible feasibility study was discussed. The consensus of the Council was to have the Administrator put together a proposal for a feasibility study to bring back to the council.

b. Solid Waste Haulers

Mayor Lein discussed the possibility of changing the structure the city currently uses for issuing waste hauling licenses, the idea is to limit the number of haulers,

with the goal to reduce the amount of heavy traffic and wear on the city streets. Council directed staff to look into the concept further.

Council Member Evenski suggested offering the Community Center membership at no charge to fire fighters as a way to encourage a healthy life style option. After discussion the direction to staff was to offer the Community Center membership to fire department members, full time city employees and elected/appointed officials at no charge, and to implement the change in the fee schedule this December to be effective in 2019.

Mayor Lein informed the board that he had started a Facebook Page to communicate what the council is doing. Most recently he shared about Winkler Park and the Water Treatment Facility. As a result he has received a call and will be meeting with a developer.
