# 4. VISITOR'S PRESENTATIONS, PETITIONS, CORRESPONDENCE

John Hendel, Fire Dept Relief Association Treasurer was present to talk about the recent Drive In which had record attendance, and to thank the City for it's support & commitment to the invent. He also shared that the Benton Lake Watershed District is discussing a fund raiser this winter that would be taking place on Lake Benton, he inquired what requirements the City would have to allow the fund raiser.

#### 6. COUNCIL BUSINESS

a. Preliminary Tax Levy
-Resolution 18-20

City Administrator Dickson explained the Tax Levy process and the proposed preliminary levy. After discussion a motion was made by Council Member Spates, second by Council Member Szaroletta to approve Resolution 18-20 Approving the 2019 Preliminary Tax Levy and General Fund Budget. After a roll call vote the motion carried unanimously.

# b. Water Tower Cleaning

Discussion was had about the water tower cleaning proposal. The consensus was to table the request and have Administrator

Dickson get answers to some of the questions raised and bring information back to a future Council Meeting for further discussion.

# c. Community Room Carpet

After discussion a motion was made by Council Member Evenski, second by Council Member Bruss to accept the bid from Bergmann Interiors for carpet replacement in the Community Room. Motion carried unanimously.

## d. 2018 CIPP Project

Aaron Schmidt, from Bolton & Menk Engineers, explained the CIPP Project and bidding results. After discussion, a motion was made by Council Member Spates, second by Council Member Szaroletta to award the contract to the low bid from Insituform for \$61,543.61 with council direction to explore expanding the scope of the project to the full 2018 budgeted amount.

#### e. Winkler Addition

Mayor Lein discussed a community park build concept with the council whereby the City would fund the original build of the park, but be reimbusred the costs of the project by the developer as lots are sold. A motion was made by Council Member Bruss, second by Council Member Szaroletta to ask the park board to convene and work on a plan to present to the council at the first meeting in December for a park with a parking lot not to exceed \$150,000. Motion carried unanimously.
