As of now, Lyndon Robjent, Carver County Engineer has responded back to Mayor Lein's email that "Mn DOT is planning to delay finishing the design documents for the project until they have addressed your concerns." A future meeting is being discussed that will include Mn DOT, Township Officials, Carver County, and Cologne Council members.
